TLIF2080 Safely Access the Rail Corridor

Course overview:

This is an induction training package specifically designed for persons working in the Transport for NSW Realm (Sydney Trains, NSW Trains, Sydney Metro) and is delivered under license to Transport for NSW (TfNSW Course SX52).

Training and assessment includes **TLIF2080 Safely access the rail corridor** which is a national unit of competency developed to meet the applicable legislated rail safety requirements including acts and regulations from the applicable state or territory together with any nationally approved compliance codes and/or quidelines.

Prior to attending this training applicants must:

- Provide a government issue photo identification
- Provide a valid USI. (if you don't already have a USI it can be generated at the following location: www.usi.gov.au

Upon successful completion of this course participants will receive a Statement of Attainment (SOA). Please note that the SOA in itself is not enough to work in the rail corridor.



NOTE - Following successful completion of training you must apply for and be issued with an RIW card as follows before work in the rail corridor.

Issue of RIW Card:

In order to receive an RIW card, participants must arrange with their actual/potential employer to apply for an RIW card. This requires individuals to complete the 100-point id check and a registered company submitting the individual's Statement of Attainment together with a Category 3 medical assessment to the RIW Card Provider (MTA).

Applicants will require a Category 3 medical certificate issued by an authorised medical practitioner (ref https://www.riw.net.au/authorised-health-professionals/#find-an-ahp)

(Note if you are planning to later enrol in protection officer training you should arrange a Category 1 medical instead of the Category 3 assessment).

Learning Outcomes:

On successful completion of training, participants will have an understanding of rail terminology, basic signalling indications, rules and regulations for people working in the rail corridor, knowledge of a safe place, Electrical safety, personal & legal requirements of fatigue, drugs and alcohol.

Program Schedule: Typically, Weekdays 730 to 1430 subject to demand/availability (weeknight and weekend sessions available for 6+ bookings)

Attendance of a minimum 6 hours of face-to-face learning and completion of assessment tasks is mandatory in order to complete this unit of competency. Six (6) hours of face-to-face learning does not include breaks.

You will be required to arrive 15 minutes ahead of the nominated start time to confirm all enrolment details are completed.

Location:

The training is conducted at Swetha International Pty Ltd training rooms at:

 Suite 23, Level 2, 12 Railway Pde, Burwood (adjacent Burwood Railway Station)

We will also come to you for bulk bookings (conditions apply)



To attend training on the day you must:

- Have confirmed enrolment details and paid the course fee
- Bring a pen to take notes and complete the assessment
- Provide a government issued photo ID (driver's license etc).



If you have any special circumstance, which may need to be adhered during the study or assessment of this program please speak to one of our personnel so that we are able to assist you. Fees and Enrolment:

The course fee includes workbook and assessment material.

Participants must provide payment, a **completed enrolment form and USI number** before training day.

We also provide a combined training and medical assessment package which provides a substantial cost saving if the required medical is arranged separately.

NOTE: Same day RISI Training and Medical are available at Burwood.

Cost for issue of RIW card and uploading data to rail industry worker onsite system is additional to the course fee and payable to RIW Card provider (currently \$100 + GST).

Assessment

Learning and assessment activities will be conducted by our assessor using a range of evidence gathering techniques throughout the course, including written and practical demonstrations. Your trainer will provide you with any support you may require with your assessment throughout the training.

If you are assessed as "Not yet competent" on the first attempt, you will be given another opportunity to demonstrate your competence. If you are still not successful after this, you may need to reenroll and repeat the unit of work.

Pre-requisites

This course requires you to read, write and communicate in English. If you are unable to demonstrate that you can communicate effectively in English and have the appropriate literacy levels to participate in this program you will be required to complete a simple language, literacy and numeracy test before attending training.
